

## Telematics Car Insurance Terms and Conditions

### Overview

This document is applicable to all products provided by My Policy Limited and should be read in conjunction with our General Terms of Business Agreement; you can access a copy at [www.mypolicy.co.uk](http://www.mypolicy.co.uk). You should read the Terms of Business with other insurance documentation, including the information issued to you by My Policy Limited and any information provided to you by your insurance intermediary and your Insurance Company.

At My Policy, we focus on providing customers telematics-based motor insurance products. Our primary aim is to act honestly, fairly and professionally and in the customer or potential customer's best interest. To achieve this, we give customers information they might need to understand its relevance in a timely manner so a customer can make an informed decision. The objective of the information in this document is to explain the terms and conditions which apply to the Telematics products we provide; the information in this document gives you detailed information about specific Telematics insurance terms which form your contract of insurance.

### Definitions

**My Policy, We or Us** means My Policy Limited and where applicable another Insurance Intermediary approved by us as a distributor of our products.

**Customer, You, Insured, Policyholder** means the customer.

### How does telematics work?

A feature of a Telematics policy provided by My Policy is the ability to view information relating to your driving style through our website; it is safe, secure, and simple. A dashboard view allows you to proactively manage your driving behaviour, shows you your mileage and ultimately allows you to control how your premium may be influenced. This feature is best illustrated using examples, for instance, if you exceed the declared annual mileage, you will be able to view online information on the dashboard specifically relating to the number of miles used, enabling you to manage the future number of miles you might use rather than pay for extra mileage.

Another example is the ability for you to learn from poor driving behaviours. If your dashboard records any 'high risk' journeys you can review the specific reasons such as speed or excessive braking. You can then modify your driving for any future journeys.

### Main Benefits

Your Telematics policy through My Policy provides several key benefits including:

- Feedback on your driving and suggestions on how to improve your driving;

- Tracking services to help locate your vehicle if it is stolen;
- Improved claims handling as telematics data can provide independent, objective evidence in the event of an accident;
- If no claims have been reported during the current period of insurance, this may be reflected in your renewal premium.

## **How is the telematics device installed?**

When you buy a motor insurance policy from us, you will either have a telematics device that is professionally fitted by our third-party installation network or you will be sent a device that you will fit yourself. The information you supply to us will dictate which type of telematics device is most suitable for you, for example: cars made before 2002 may not be compatible with our self-install device.

You will know which type of device you will be required to have when you purchase your policy online.

Different fees and charges may apply depending on which type of device you have, for full details please see the Fees and Charges section on pages 6&7.

## **Professionally installed device**

We may tell you that your telematics smart box will need to be installed by our third-party installation network. This is a small telematics device, about the size of a smartphone that tracks your driving.

You will need to make an appointment to have your device installed. You will then be contacted to have your appointment confirmed. You must get your device fitted within 7 days of the start of your policy, otherwise your policy will be cancelled (see "Failing to install the Telematics Smart Box within 7 days section").

You need to make sure everyone who drives the car, such as your partner, is aware that the device is installed. The person who installs the device will also take a photo of your car. We will use this to check it matches the description you gave us.

## **Self-install device (plug in)**

We may tell you that you will need to install your own telematics smart box. If this happens you will be sent a telematics plug in device by post. This device is about the size of a matchbox that plugs into your car's OBD port (this stands for On Board Diagnostics). Full instructions on how to install it will be included with the device.

Installing the device is simple and should only take a few minutes, once it's plugged in for the first time, the device will automatically activate.

You must plug in your device as soon as you receive it, failure to do this within 7 days from the start date of your policy will result in cancellation of your policy (see "Failing to install the Telematics Smart Box within 7 days section").

You need to make sure everyone who drives the car, such as your partner, is aware that the device is installed.

At the end of your policy we will contact you with instructions on how to send the device back to us, including a pre-paid returns label.

## Telematics Smart Box Installation & Maintenance

Neither the Insurer nor My Policy Limited can be held responsible for any defects relating the Telematics Smart Box e.g. defects in its design, materials, or workmanship. Any warranty provided by the manufacturer of the Telematics Smart Box does not apply to any item which is part of the insured vehicle and which is used in conjunction with the Telematics Smart Box (e.g. the battery for the insured vehicle). The maintenance of such item is the responsibility of the policyholder.

## Unusual restrictions

Unusual conditions are generally deemed to be those which are not usually associated with a normal car insurance policy but are specific to the operation of a telematics policy. We want to make sure you are fully aware of these, such as buying more miles if are likely to use up the annual estimated mileage. Full details of these conditions are explained throughout this document.

Your Telematics car insurance does not contain any specific restrictions concerning curfews unlike other telematics policies which typically place restrictions on where or when a vehicle can be driven. However, your Telematic Smart Box data will provide information of all journeys including those times when driving represents a higher risk, such as at weekends and late at night and this usage shall form part of your overall driving score. We therefore advise more caution at these times.

My Policy will explain any specific restrictions before you take out your policy and each time you renew your policy.

You will also be able to access information about your journeys through the online dashboard, such as information relating to mileage, usage and driver scores. We strongly suggest you use the information to manage your driving as ultimately, driving behaviour influences the premium you pay.

## IMPORTANT - excessive speed conditions

When your car is driven in a dangerous or unacceptable manner and statutory speed limits are exceeded the following conditions shall apply:

The Telematic Smart Box data will trigger a notification to us, and we will contact you. If the excessive speed limits detailed above are recorded, your policy will be cancelled regardless of the allowable number of high-risk journeys, because the vehicle was driven in a dangerous manner at speeds shown above. We will notify you of this in writing by sending a 7-day notice of intended cancellation to the email address you have provided.

## Changes to your premium

It is important to understand that any material changes notified to your insurer may impact the premium you are required to pay.

Material changes in this context are matters such as telling us about a pending motoring conviction, a change in your occupation, and/or you start using the vehicle for something other than what you told us previously. It is anything that is relevant to the insurers providing cover for the risk you want insured.

To illustrate this point, if you purchased several mileage top-ups during the lifecycle of your policy it will affect the yearly amount of premium you might be expected to pay at renewal time.

In the same way, if you have made or notified us of a claim or other changes in your circumstances these will be considered when we calculate renewal of your policy and as we and your insurers gather more data, we will adjust our rating models on an ongoing basis. As is common with most insurers this will affect our assessment of future risks and premium payable.

My Policy will provide you with a premium statement and highlight any unusual conditions relating to premium.

## Mileage (this affects the premium you pay)

Your premium is significantly influenced by the number of miles you consume during the lifecycle of your policy as your initial premium is typically calculated based on the annual mileage you declare at the outset. Your Telematics Smart Box will monitor your mileage and you can view the amount you have consumed as well as your predicted annual mileage via your online dashboard.

Based on your mileage usage, the Telematic Smart Box will generate details of whether you are predicted to exceed the declared annual mileage. If within the first 30 days of inception or renewal, you are predicted to exceed your annual mileage by 100% or more, we will contact you to discuss your options and you will need to purchase a minimum of 50% of the predicted excess amount.

Example: You declare an annual mileage of 6,000 and are predicted to need an extra 6,000. This will mean that your total annual mileage is likely to be 12,000 or more. You will be required to purchase a minimum of 3,000 additional miles to enable your policy to continue.

We may deem that the policy may be unsuitable for your needs and this could result in cancellation.

If you do not contact us, you will be issued with a 7-day notice of intended cancellation by email.

**If your predicted mileage is likely to exceed the monthly average amount of miles (this is based on the amount you declared as your annual mileage) you must top up your mileage allowance to enable your policy to continue.**

## Driving Scores

What data does the Telematic Smart Box measure?

- Acceleration
- Braking
- Speed
- Cornering
- Time of use
- Mileage
- Types of roads used e.g. motorways, country lanes
- Location of vehicle

The Telematic Smart Box measures all of the above information but it is not limited to just those. For example, combining some of the above together means the box can also help us measure individual driving styles and pinpoint the individuals who are most likely to practice them so we can alert them to reduce the risk that they pose to themselves and other road users.

**The Telematic Smart Box will generally collect all of the above information including real-time data as you drive. What must be considered is that the Telematic Smart Box cannot distinguish between drivers.**

In short, we will continuously measure and record how the vehicle is being driven and where appropriate, report this information to you. It is your duty to make all persons who will drive the insured vehicle aware of the Telematic Smart Box and the implications of their driving behaviour.

All scoring will go against the Policyholder and not the alleged driver at the time.

## IMPORTANT - Driver Score Implications

Journeys are scored between +10 and -10 and categorised into three levels. The table below details the score implication process:

## Assessment at Renewal

We will review your telematics data at each renewal cycle. This analysis will influence the renewal terms offered and conditions imposed. We will not be able to offer any new business rates because of this analysis. My Policy will explain the charges, conditions and limitations that apply including any unusual characteristics separately and as part of your renewal notification.

## IMPORTANT - Fees and Charges

As referenced in our General Terms of Business Agreement, Telematics policies are subject to specific fees and charges and these are set out in the table below.

## When must I fit the Telematics Device?

The Telematics Smart Box must be fitted to your vehicle within seven days of the start of your policy and must remain operational for the entire time your policy is in force, including any subsequent renewal.

### Failing to install the Telematics Smart Box within 7 days

If the Telematics Smart Box is not installed within 7 days, we will contact you (using the contact details you have provided). We will explain that your policy will be cancelled in 7 days because either, you have failed to fit or failed to arrange for an engineer to fit the Telematics Smart Box within 7 days. We will confirm this to you by e-mail providing you with a 7-day notice of cancellation.

If the Telematics Smart box is not installed because **you** fail to attend the appointment, or the vehicle is not as you described when you took out your policy, you will be charged a £50.00 fee for the failed appointment.

This fee will either need to be paid in full or added to your current direct debit within seven days of the failed appointment. If you do not arrange payment within this timeframe, your policy will enter cancellation and we will confirm this to you by issuing a 7-day notice of cancellation via email.

You can be charged a £50 failed appointment fee for the following reasons:

- Failure to attend the appointment.
- If you cancel an appointment with less than 24 hours' notice.

Upon the engineer attending the appointment they discover:

- The vehicle is not as you described when you took out your policy, for example the vehicle has been modified and these modifications have not been disclosed to us or your insurer.
- The vehicle is not fully functional, for example there is a warning light on the dashboard.
- It is not safe for the engineer to carry out the installation, for example, due to the condition of the vehicle or the vehicle is not parked in an accessible and safe location, or there is inadequate space for the passenger door to open.

This is not an exhaustive list.

## Cancellation

You are entitled to cancel your policy for any reason both within the statutory 14-day cooling-off period and outside of it. During the 14-day cooling off period cancellations will be subject to a charge for the period of cover you have used. For cancellations outside of this period, we have listed the specific cancellation terms that your insurer will apply when calculating refunds. We also reserve the right to cancel this agreement at any time and if we do so, we will notify you in writing by sending a 7-day notice of intended cancellation to the email address you have provided.

Additionally, the fees described in our Fees and Charges Table on page 8 will also apply and we reserve the right to deduct any amount due from any premium refund that may be due to you.

### **Installation:**

It is a condition of your insurance Policy (arranged under the terms of your contract with My Policy Limited) that you have a fully operational **Telematics Device** (alternatively known as a Black Box) installed in the **Insured Vehicle**. The **Telematics Device** will be fitted by our approved engineers who are fully competent to carry out the work to the required standard. It is your responsibility to obtain permission from all parties who may have an interest in the **Insured Vehicle** (e.g. a hire purchase or leasing company) before the **Telematics Device** is installed.
